

Terms and conditions of business and participation trainings + events

1. Registration and confirmation

Registrations will be considered in the order of their receipt. In principle, these conditions apply and are accepted with the registration. The organiser reserves the right to limit the number of participants, to adapt the content and to make changes to the dates or programme. The data received with your registration will be processed electronically for participant administration.

2. Fees

The participation fee applies - if not marked separately - for one person and is exclusive of statutory VAT. We reserve the right to change prices in the event of changes to the duration of the event. The printed prices lose their validity with the publication of the subsequent event brochure.

3. Withdrawal / Cancellation

Cancellations must be made in writing and the withdrawal must be declared at least 28 days before the respective event date. In case of later cancellation, the full participation fee will be charged.

Cancellations after this time or no-shows without cancellation will be charged the full fees. Cancellation fees do not apply if a substitute participant is provided.

4. Copyrights

The event documents may not be reproduced or passed on to third parties without the express permission of the organiser.

5. Data use and data sharing

a) Public training and courses

Personal data will be used by GS1 Germany exclusively in the context of the handling of and courses electronically stored and and processed. These are used exclusively for the fulfillment of contractual obligations (Art. 6 para. 1b DSGVO, on the basis of your consent (Art. 6 para. 1a DSGVO) or on the basis of legal requirements (Art. 6 para. 1c DSGVO).

b) Other Events

The other events of GS1 Germany as well as the cooperation events offered primarily serve the purpose of networking as well as the mutual exchange with the most important players of an industry, also after the event. Such networking can only take place by GS1 Germany making

available to other participants – including the participating GS1 Germany Solution Partners – the name of the respective participants, the name of the company for which the respective participants work and the designation of the respective position. This will take the form of publication of the data on a list of participants, which will be sent to all participants.

This type of data processing serves to protect the legitimate interests of GS1 Germany or a third party, within the meaning of Art. 6 (1) p. 1 lit. f GDPR. The legitimate interest of GS1 Germany is based on offering participants the opportunity to contact other participants or to be contacted by other participants. Furthermore, we would like to create the best possible conditions for networking for all participants. The data processing is necessary, moreover, the legitimate interests of GS1 Germany outweigh the interest of the participants in not disclosing their data.

c) Use of data

GS1 Germany is entitled to use the participant's data - in particular the electronic postal address - for direct advertising for its own similar goods or services and to pass them on to an external provider for the creation of digital certificates, proofs or attestations.
