1 General information and purpose of the guide

In this guide you will find instructions on how to use the GS1 DQX Upload Tool for your GS1 DQX operation to provide product images/artwork of your products for the visual validation process.

- At GTIN level, you have the option to choose whether you want to use this delivery route or the standard route via GDSN.
- Mixing supply channels for one GTIN is **not** possible. If product images/artwork via the GS1 DQX Upload Tool are available, **only** these will be used for the visual validation.
- The product images/artwork provided via the GS1 DQX Upload Tool are provided exclusively to GS1 DQX and only for the purpose of visual validation. **These files are never dispatched to other data recipients.**
- The maximum file size must not exceed 10 MB.



Follow these steps to upload product images or artwork of your items via the GS1 DQX Upload Tool:

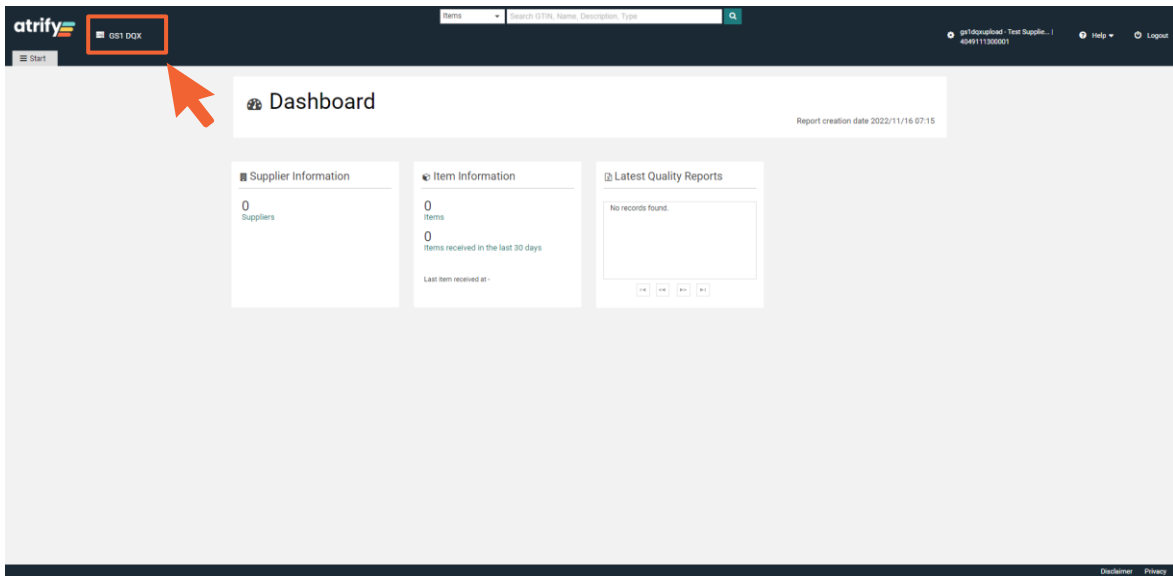



Figure 2 - 1: Dashboard

All GTINs published by your GLN to GS1 DQX appear in the list.

Stock items, that is, articles that were sent in the initial load and are currently NOT_RELEVANT, are hidden by default.

You have the possibility to directly select a GTIN to which you want to add product images or artwork.

- To do this, click on the GTIN.

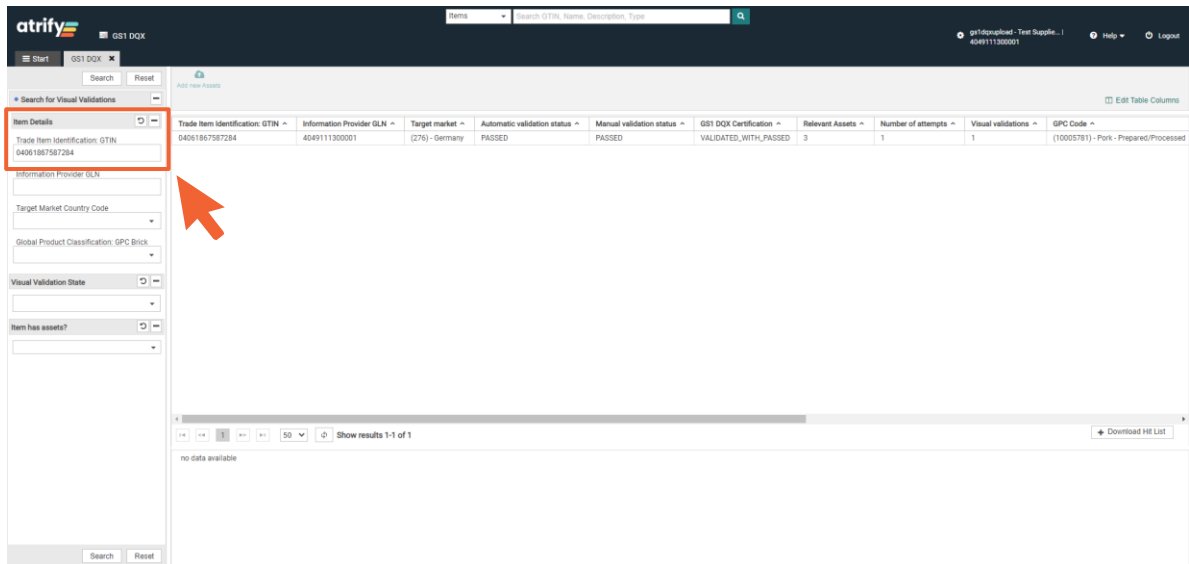


Figure 2 - 3: GTIN search

You have the possibility to search for a GTIN.

- To do this, enter a GTIN in the search bar (left).

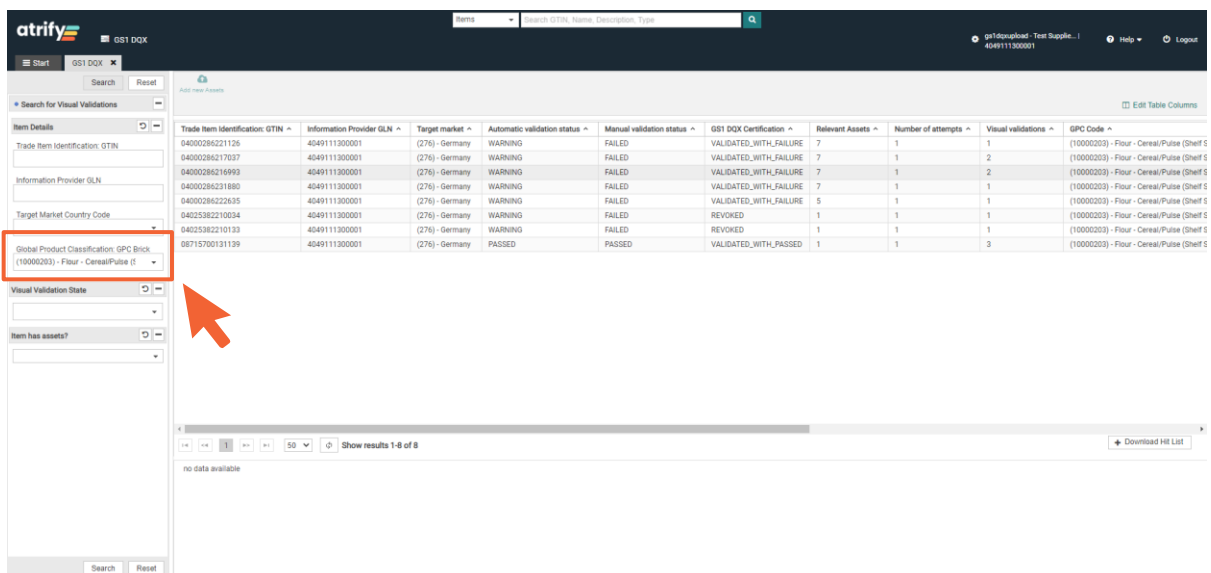


Figure 2 - 4: GPC search

You have the possibility to filter your GTINs by GPC Brick to simplify your search.

- Set the following filter (left): "Global Product Classification: GPC Brick".

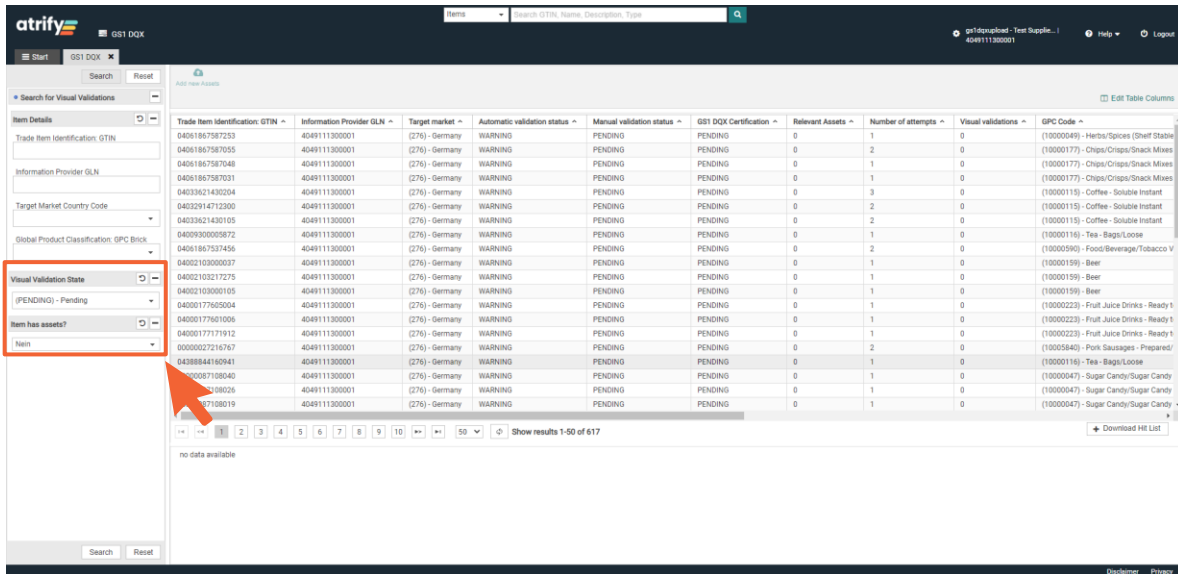


Figure 2 - 5: Set filter

You have another option to filter your GTINs to simplify the search for GTINs with the visual validation status PENDING and without digital attachments.

- To do this, set the following filter (left): "Visual validation state"¹ & "Item has assets?".

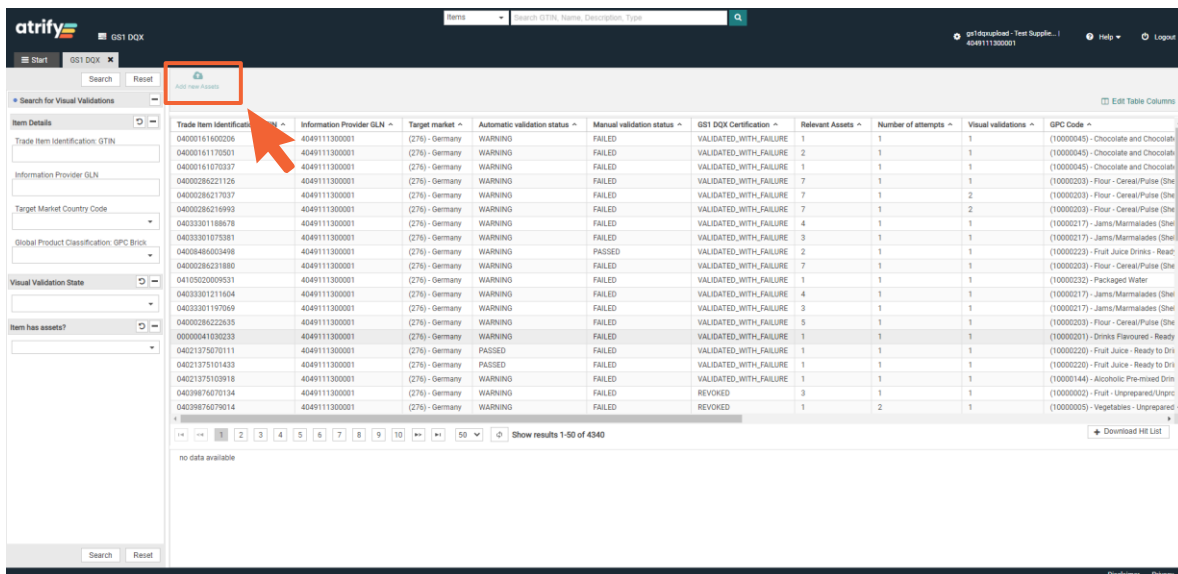


Figure 2 - 6: Add product images/artwork

Once a GTIN has been selected in your overview, you can add product images or artwork to it.

- Then click on "Add new assets".

¹ Here you also have the option of filtering for stock items (NOT_RELEVANT).

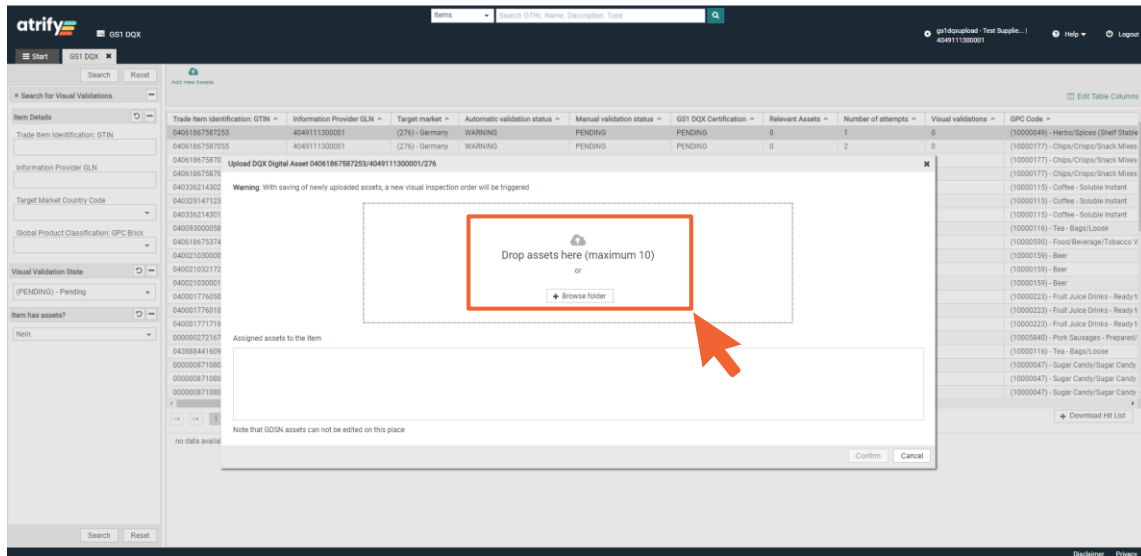


Figure 2 - 7: Upload dialog

Clicking on "Add new assets" will open an upload dialog window.

- Load product images or artwork via Drag&Drop into the dialog window or
- Open the folder view by clicking on "Browse folder".

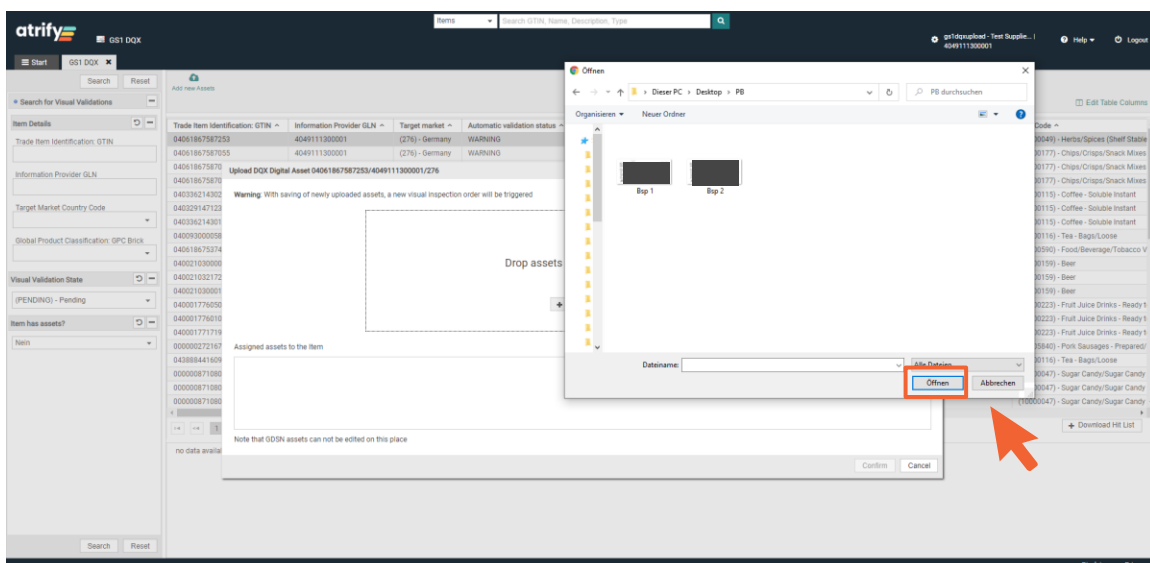


Figure 2 - 8: Add product images/artwork

With your click on "Browse folder" the personal folder structure of your computer will be opened.

- Select the relevant product images or artwork and click "Open".

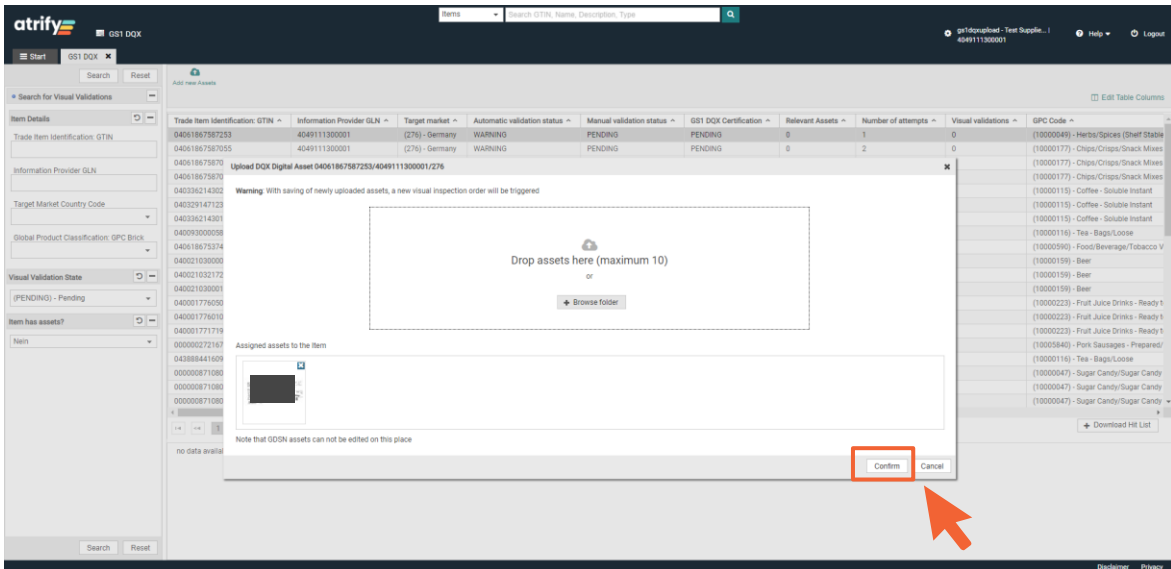


Figure 2 - 9: Confirm upload

Once the selection of the product images or artwork is complete, confirm this.

- To do this, click on "Confirm".
- Your click triggers a visual validation.

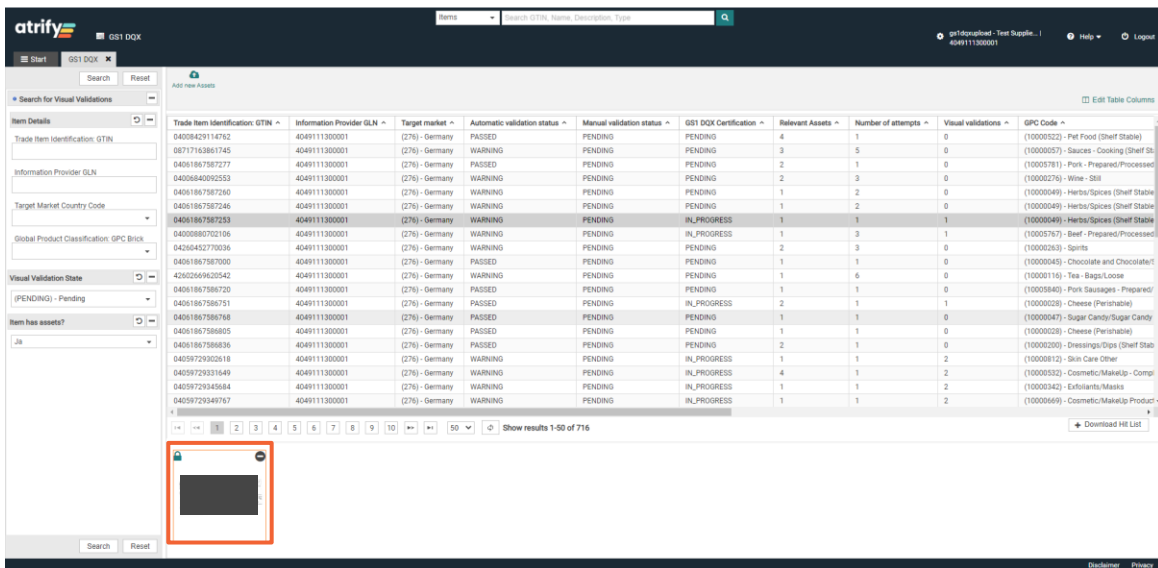


Figure 2 - 10: GS1 DQX list - GTIN with product image

The product images or artwork are now displayed as part of the GTIN.

Follow these steps to change your personal user settings:

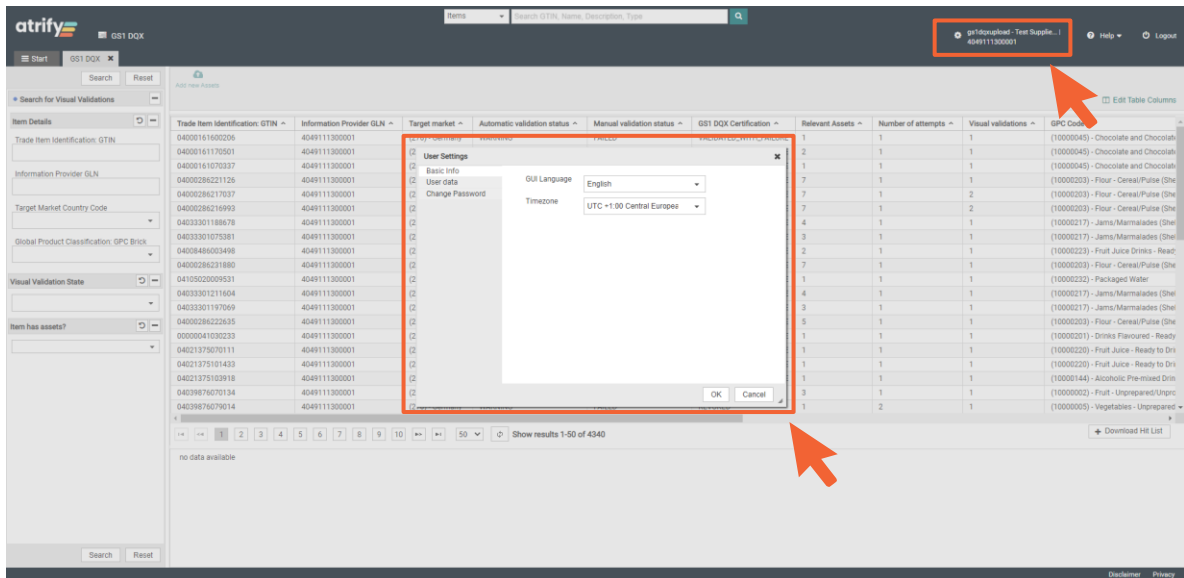


Figure 2 - 11: Change user settings

You have the possibility to manage your user settings.

This includes the language and time zone settings as well as your password.

- Click on your name and GLN in the upper right corner to enter the user settings.
- Then set your personal settings.
- Confirm this by clicking on "OK".
